General Comments
<p>A renewal inspection occurred on August 15, 2023.</p> <p>Discussion were had with educators in the rooms regarding room arrangement, ratio questions, displaying creative art materials, (having them available, in covered containers, but not accessible to young children except under direct supervision), music walls and chalk painting the shapes in the outside play area, cozy furnishings in the quiet areas, changing of toys that children are no longer engaging with for other items, art easels and hanging art to dry on a wooden drying rack.</p> <p>Discussions were also had with educators about quiet time. Children may not require a long quiet/down time, if they are not sleeping. Discussed taking the children outside and utilizing the outside play area when the younger children are sleeping. Regulations state a minimum of two hours a day when the majority of children are present, outside time can exceed that, especially if the children are engaged in outside play. Snack/lunch can be done outside, providing children come into the facility prior to eating and wash their hands.</p> <p>Inclusion was also discussed with the Administrator that it was recommended that she reach out the Early Learning Consultant with her questions.</p>
