General Comments

A Monitoring Inspection was completed this morning. Inspector, Jodi Hennessey, and Quality Assurance Monitor, Cathleen Leblanc, completed today's inspection. Children were observed during inside play, snack time, and transitioning to outside play. 3/4 Room - Educators were observed making homemade donuts with the children. St. Patrick's Day decorations and activities were observed. Cat grass was observed growing, in cups, on the windowsill. 2/3 Room - Children were observed sitting at a table, playing with Play Doh. Children were also observed reading books, in their new Dinosaur reading tent, and playing with animal themed magnets. 2's Room - Children were observed playing with their play kitchen, making pretend hot chocolate and cookies for their friends and educator. Children were also observed getting ready for outside play. Infant Room - Children were observed sitting on the floor with their educators, taking part in car play, and looking at books. Children were also observed getting ready for outside play. Documentation - Several forms of up-to-date documentation were observed throughout the facility - learning stories, children's open-ended artwork, and photos. Positive Child Guidance Techniques were observed in all rooms – educators giving gentle reminders, offering choices, using positive reinforcement, and offering children the opportunity for new activities. A conversation was had with Administrator regarding Public Health outbreaks. Incident reports are required to be sent to Quality Assurance Monitor, for all outbreaks.
