General Comments

A monitoring inspector occurred on December 16, 2025.

Four new staff files were reviewed by the Inspector and verified complete.

Discussed with Administrator purposely planning and documenting the children's learning. Educators indicated that they post pictures of the children engaged in activities to a private Facebook page. Recommending that these postings also be placed in a binder for review by licensing staff during inspections. Children's learning should be documented and displayed on the walls for the children and families to be able to revisit their experiences and for educators to building on the children's learning and interests.

Administrator indicated that the Early Learning Consultant-Curriculum, is scheduled to be at the childcare facility in January to assist with room arrangement, curriculum, documentation, and any areas that the operators feel the facility requires assistance. Recommending that when working with the Early Learning Consultant that the facility start with the 3/4 year old room. To assist with room arrangement and interest centres.

Children were observed by the Inspector engaging in play in the fenced in play area, inside play area lunch, and nap/quiet time.
