General Comments

Upon Licensing staff arrival, the 2-year-old classroom and 3-year-old classroom were outdoors playing while the infant classroom was up morning snack and reading stories.

The outdoor play space for the preschool age children was fully fenced and play material such as balls, trucks, a sensory wall, a mud kitchen, basketball nets and a playhouse climber with slide were in good condition. Please remember to rake your mulch around the playhouse climber with slide to ensure proper protective surfacing. During outdoor play, music was playing, and Educators were engaged in play with bubbles and water play. Later in the morning the infants went outdoors to play. The infant outdoor play space was tidy with a pergola and windchimes. Play material such as trucks, balls, a small slide, and blocks were in good condition. Educators were observed sitting with the infants on the mat playing, signing, and holding hands. Please ensure that the temporary sunshade or sail is in place on sunny days.

Before lunch, all classes returned inside. Proper hand washing was observed, and Educators prepared the children's lunches from home at tables. Educators were observed sitting with the children and helping with packaging when needed. After lunch, tables were cleaned, floors were swept, and nap mats were laid out. There is evidence of a daily routine as the transition between lunch and nap/quiet time was smooth. Calm music was played in each classroom and Educators were observed rubbing the backs of children and sitting with them to help them fall asleep. Children who did not nap were observed reading books in cozy corners, playing with playdoh and were drawing. Educators were also observed planning during nap / quiet time and preparing for afternoon activities. Afternoon snack was observed and where the weather was very warm the day continued indoors with tabletop activities, sensory play and stories.

During inspection, child and staff files were verified and all required documentation was present. Monthly fire drills and daily attendance are being logged and completed. Children's artwork, current learning stories, and web planning pages were on display in the hallways and classrooms. Evacuation plans and allergy information was posted, and the parent board contained required licensing information.

Licensing staff recommends for renewal.
