General Comments

Upon Licensing staff arrival, both the preschool age children and the school age children were outdoors playing in the adjacent field/wooded area. Water bottles were readily available, and children were observed playing with a parachute and using imaginative play in the woods. As a reminder, preschool age play areas are to be enclosed by a securely gated fence. The field and wooded area are only to be used for planned learning or physical activities, not a primary play space.

Later in the morning both classrooms returned indoors, and proper hand washing was observed. The indoor classrooms were organized and tidy. Play material in the 4-year-old class such as wooden blocks, Lego, dinosaurs, sensory bins, a wood play kitchen, and a cozy corner with literacy material were in good condition. The school age classroom had a large chalk board wall with defined stations listed. Children were observed playing in stations with material such as Lego, drawing, reading, and dressing up.

During lunch, Educators in both classrooms were observed sitting with the children and were actively engaged in conversation. After lunch, the tables were washed, and the floors were swept. During quiet time, Educators were observed drawing, working on a puzzle, and playing a board game with the school age children and in the 4-year-old class, the Educator was observed reading a story to the children in the cozy corner and later sitting with them building with wooden blocks.
