<p><b>General Comments</b></p> <p>Licensing Staff arrived at the facility to conduct a Monitoring Inspection. Upon arrival the children were sitting at small tables eating morning snack. The classroom was bright, welcoming and organized. Several positive changes have been made in the classroom since the last Monitoring Inspection. A large new wooden arch/shelf has been recently added. Colorful silk scarves were woven through the top and the Educator stated they are planning on adding string lights as well. In the shelving area, several wooden loose parts, plants, colorful wooden peg people and a fairy were observed.</p> <p>The Educator explained that today they were surprising the children with a magic show. After morning snack, the children engaged in free play. Some groups of children were observed reading books to one another while others played with safari animals. A group of children asked an Educator to put on some music so they could have a dance party. The Educator danced and sang with the group, teaching them different dance moves. A gentle reminder was heard before the Educator put on a cleanup song. Once the classroom was tidy, the children gathered in the music area on a large rug with an Educator. The group went over the plan for the morning and the expectations for when they attend a special event. The children lined up by the door and a headcount was observed before the children walked to the cafeteria to watch the Magic Show.</p> <p>As lunch time approached the group lined up and walked back to their classroom to prepare to eat. The children washed their hands before getting their lunch boxes, water bottles and finding a table to sit at. One Educator was observed setting out cots for quiet time as the children ate. Only positive child guidance was observed during today's Monitoring Inspection. It was evident there's a mutual respect between the children and Educators. Lots of praise and encouragement was heard this morning. The children appeared comfortable and familiar with the environment and Educators. A wide variety of pictures, current learning stories and artwork were displayed throughout the indoor environment.</p>
