Comments: During Monitoring Inspection, it was noted that the Gym was not set up for the children. Shelving, tables, chairs, and materials are stored in the classroom. Each environment must be set-up and ready for children daily. QA Monitor discussed with administrator on site.

Comments: Surfacing under playground structure pooling. Ensure surfacing is raked regularly to prevent pooling under structure and spots where surfacing is compacted. Rake to be purchased.

<p>General Comments</p> <p>Monitoring Inspection:</p> <p>Children and educators observed engaged in a variety of activities this afternoon including open-ended art, dramatic play, mini basketball, and outdoor play. Purposeful planning is evident through documentation on planning sheets, materials and invitations that have been added to the environment that support the children's current interests (forts, basketball, art and doctor).</p> <p>A wagon filled with balls, chalk, books, buckets and shovels is accessible to children during outdoor play. The children were observed exploring the puddles from the recent rain with buckets, scoops and containers. They were exploring mixing, pouring, dumping and the movement of the water. How can you document this? What materials can be added to the environments to expand on this emerging interest?</p> <p>QA Monitor discussed with administrator on site the excess furniture for the gym environment that is currently being stored in the classroom environment, this is taking up space in the indoor play area and causing clutter to accumulate. Furniture must be moved to the gym when program is running.</p> <p>Hand washing routines observed after outdoor play and before snack. Yogurt and cereal were served for snack. Monthly fire drills are documented. New staff file (3) review was completed, all required documents are in place.</p>
