## General Comments

Monitoring inspection completed.

Upon arrival, 3 staff were observed sitting and eating lunch with the children.

Lovely inviting indoor play environment where children can easily move freely between areas- it was nice to see a book corner, an area for children to play games, sit at tables or on the floor to build with blocks, etc.

Staff were engaged with children, and everyone transitioned into quieter activities and ample time was provided over an hour after lunch. Children were observed building structures with wooden blocks, making snowflakes with construction paper, playing War (card game), making things with magnetic blocks, lego etc. All children played cooperatively, and staff intervened appropriately and used positive language to redirect when children disagreed. I would suggest staff reflect with children on incidents by helping them understand the consequences to their actions and words.

Staff brought all the kids together to discuss afternoon activities in the gym. The educator explained instructions in words easily understood by this age group. All children and staff moved into the gym area and they were given a choice of activities. Staff added a positive moment to their day and some children were selected to get a sticker because they were observed playing and treating their friends with kindness and respect and playing cooperatively. This is a really nice idea, however, please ensure staff find opportunities to show every child something positive they have seen in each of them during the day.

Administrative records were reviewed, and child attendance is being completed and staff records were reviewed. Please read comments above. One of the soccer nets needs to be removed from the outdoor play area as the metal is broken or if possible, to repair.

The license posted is from the previous centre. Please post your new license.

After speaking with the administrator, he explained that the owner is in the process of changing the signage and all the forms on the parent board to reflect the new business name. The administrator's name should also be posted on the parent board.
