Comments: Deficiency is now compliant. During the visit, licensing staff observed an educator with a coffee in the outdoor play area. Licensing staff asked the educator to not drink coffee in the children's play area. This was corrected during my visit.

Upon arrival, children and staff had returned from a morning at Deer Park (2 hours) and children were sitting eating lunch. Children are attending FT over March Break and staff have planned a number of activities this

week. Today children will be participating in a few science experiments. An outdoor experiment will involve making different kinds of pop explode into a Volcano. Children voted on the pop they thought would make the biggest volcano. During my visit some children that finished lunch early had moved to the gym area and were playing dodge ball. Licensing staff observed some dodge balls that need replaced or repaired. The foam is showing and makes it difficult to clean and sanitize. The other group of children remained on the other side and were playing with magnetic blocks, board games, puzzles, and blocks. All staff were observed actively engaged in conversation with the children. Staff seem to easily redirect and provide lots of choices.
