Upon Licensing staff arrival, the children were having lunch in the main room. Once finished lunch, the room was cleaned up and the children went outside to play.

General Comments

The outdoor space was large with a wooden gazebo where children were observed colouring at a picnic table while other children were playing with soccer balls and nets, basket balls and nets, or in in small groups chatting as friends. Educators were observed to be spread out maintaining clear lines of sight and were engaged in conversations with the children.

Later in the afternoon, the children came indoors to play. Outdoor shoes were changed, and children split into two groups. One group moved into the main room to work on a Remembrance Day craft or at break away stations with wooden blocks, Lego or doodle drawing tablets, while the other group played in the gym with mini sticks and the exercise mats to create an obstacle course. Positive child guidance was observed throughout the inspection, and an Educator was heard saying "one, two, three, eyes on me" and "thumbs up if you can hear me" during transition time.

Monthly fire drills have been completed and logged as well as required cleaning and outdoor maintenance checks. As a reminder, please update your parent wall with your Inspector/Investigators name and contact information (Nancy Glendenning).
