General Comments

Please post your new license. This was emailed to the Operator on December 6, 2023. Also please ensure the annual inspection is posted on the parent board. Licensing staff observed it posted by the printer next to staff station.

Upon arrival, children were observed in the front room and in the gym. There were 6 staff on site - see comment above.

Administrative Records were reviewed and fire drills, incident reports are being recorded. See comment above. Children were observed building a structure with wooden blocks, making things with play doh, building with lego, drawing, playing with magnetic blocks, reading, playing a game of chess, and a group of children were playing in the gym. Children had a choice of stations to participate in. It was nice to see the staff had posted the full day schedule, so children were made aware of today's activities.

Supervision was appropriate. Staff were observed speaking to children in a kind manner, engaged with children, providing instructions to children in a language that is easily understood, kneeling down at their level when speaking to them, and licensing staff heard staff say "Thank you very much for asking", and also invited children to play in the chess tournament. Children were reminded to wash hands before eating lunch.

The heater needs repaired. It is very noisy and makes it difficult for staff and children to talk at a normal voice level. Please make arrangements to have it serviced. It is a long day for children and staff to listen to the constant loud sound.
