General Comments

There have been shelving and materials added to the indoor play space. There are blocks, lego, dinosaurs, a reading area, art, and a cozy reading room to name a few. These additions have provided more choices and balance in the environment for the children.

The parking lot now has a fence which has provided a safer area for the children to play in. It includes 4 corners game, basketball, hockey, chalk, wooden benches, a shaded area, and planters for flowers.

The administrator advised licensing staff that ratio when transporting children according to the regulation is being kept at all times. The educator who is driving is not being counted in the ratio for the children.

Please be advised that as for the purposes of section 17 of the Act, the requirements with respect to the transportation of children are as follows:

(a) if the driver of a motor vehicle is a staff member, he or she shall not be included in the child-to staff ratios calculated under sections 9 and 10

(b) despite paragraph (a), the driver of a motor vehicle who is a staff member is included in the child-to-staff ratios calculated under sections 9 and 10 if the children transported are school-age children and the route taken is between the licensed facility and the school

(c) the driver of a motor vehicle and the motor vehicle must be in compliance with the Motor Vehicle Act and the regulations under that Act; and (d) the motor vehicle must be equipped with (i) a record of emergency contacts for each child receiving services at the licensed facility, and (ii) a first aid kit that is equipped with the contents prescribed under the Occupational Health and Safety Act.

Driver's abstracts for each educator showing a good driving record (can be obtained at Service New Brunswick) should be kept on file.

It is not recommended for staff members to use their personal vehicles to transport children. However, if doing so, they are to advise their vehicle insurance company. and it is recommended that a copy be kept in their file showing that they have the proper coverage.

I noticed that there was an out of order sign on one of the washrooms. The administrator on site advised me that they had fixed it and took the sign off the door. They stated that the toilet had been plugged and she

The requirements for the First Aid kits have changed as per Worksafe NB. I will forward the list to the Operator. Please ensure that expiry dates are checked regularly.
