## **General Comments**

Licensing Staff arrived at the Facility to perform a Monitoring Inspection. Upon arrival one group was finishing lunch in the front room, one group was in the back room doing exercises and another group was at a nearby park. As the children finished lunch, they were observed playing playdoh, playing cars and board games. Once all children had finished lunch, the tables were cleaned, the group in the front room switched to have time in the back room.

The children had some free play where they were given the opportunity to color, build and play games before getting ready to go outside. Once outside, the children were seen playing basketball, in the play kitchen area and playing Four Square. A discussion was had with the Manager about doing a walk-through of the playground before the children vs at the end of the day as there were several cigarette butts observed throughout the playground.

Allergies were posted and visible. During today's visit a Medication was left unattended on a table. A conversation was had with the Manager as reminder that all Medications must be kept out of reach of the children.
