Licensing Staff arrived at the Facility to perform a Monitoring Inspection. Upon arrival, all the children were together in the front room. Children were observed playing with Perler Beads, wooden train set, reading and playing in the play kitchen area. Shortly after, a third staff arrived and took a small group into the gym to play active games.

The morning routine was a bit hectic. Children were running inside and sitting on cubbies. Children were eating at the building station, walking around while eating and hand washing was not observed. A conversation was had with the Operator about the importance of a routine. The Operator had a conversation with the children, they worked together to clean up from the morning and prepare to go outside. A final headcount was observed before the group left the building.

The group in the gym were observed playing Fishes and Whales, playing with a basketball and doing an obstacle course. Once the younger group had transitioned outside, the older group cleaned up the gym and spent some time in the front room. The group was observed washing hands and sitting at the table for morning snack. As they finished eating, some children sat together to look at Pokémon cards while others made creations with Perler Beads. The group cleaned up after snack and got ready to go outside.
