General Comments			

Licensing staff arrived at the facility to perform a Monitoring Inspection. Upon arrival, there was a small group of children playing alone in the back gym area of the facility while Educators were in the front room. Please ensure an Educator is supervising in the room when children are present. Since the last Monitoring Inspection, the children have been divided into groups. The manager on site prepared a schedule for the groups to ensure all children have time in the gym and the outdoor play space as part of their daily routine.

Shortly after, a school bus arrived at the facility. An Educator greeted the children outside as they arrived. Children were divided into groups before sitting at the tables for lunch. Please ensure children are washing hands before and after lunch. Once all the children had finished eating, the groups started to get ready to go outside. While the second group was getting ready for outside, it was discovered a child had left the building without an Educator. An Educator did go outside to bring the child back in with their group. Positioning of Educators during the transition to the outdoor pay space can aid in ensuring children do not exit facility unattended. Once all children were ready, the group went outside to play in the fenced in area. Children were observed playing hockey and on a large pile of snow.

The posting board has all required documents. Fire drills were posted and are up to date. Positive child guidance was observed. The Educators were engaged in conversations with the children and spoke to the children at their level and showed a shared interest in their activities. During today's visit, an Educator had great difficulties attempting to locate a child's profile. Child profiles must be kept on site at all times and be accessible. Staff files were reviewed today. It was noted that an Educator on site did not have a staff file, therefore, the Educator was sent home. Licensing staff will continue to support facility to strengthen routines, transitions and filing systems.
