General Comments
Upon arrival of licensing staff, the children had not returned from school. As the buses arrived, the educators were observed greeting the children and taking attendance. The children brought their bags inside and went to play outside. The children were observed playing in the snow, on the snow hill, and some were playing a game of tag. The educators were engaging in conversation with the children and playing with them. The children and educators returned inside and separated into their groups. The children got their snowsuits and boots off and prepared for the activities. An educator was heard praising independence.
In the front room, the children gathered for the educator to explain the various activities that were prepared. Some children played Bingo with an educator, and others played Just Dance. In the gym, an educator explained the game they were going to play. To get the children's attention, the educators would say "If you can hear me, clap once" and the children would clap back, or would say "Hands on top" and the children would respond "That means stop". The children partnered up for a game of "shoulders, knees, and cone". After the game, the children played "fishes and whales". The groups cleaned up the space and prepared to switch sides.
In the front room, the children played with Play Doh, cars and tracks, Bingo with an educator, colouring, and some did yoga. In the gym, they were playing a game of capture the bean bag and had music playing in the background. An educator joined the game and played with the children. After the game, the educators took out mats for the children to free play. Some children were observed dancing to the music, practicing flips, and some played mini hockey. Once ratio was reduced, the front room joined the children in the gym and played together. The program offers open snack, meaning the children can take out their lunch boxes and eat snack when they are hungry.
The educators were observed greeting the parents and updating the attendance as the children left. The educators were attentive to the children and kneeled when talking to them. Ratio was more than met. Approximately 10 child files and the current staff files were checked and found to be complete. The administrator showed licensing staff an activity book they've started to pre-plan activities. Positive child guidance was observed.
