Comments: The children did not go outside before lunch. Weather permitting children are to go outside one hour in each four-hour block.			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (b) child records that include: (iv) the name, address and telephone number of at least two individuals authorized by the child's parent or guardian to pick up the child and to be contacted in case of an emergency if the parent or guardian cannot be reached,	24(1)(b)(iv)	Jan 31, 2024	
Comments: 2 files out of 5 audited didn't have the complete address of at least 2 emergency contacts. All children files must be completed before entry.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Jan 26, 2024	
Comments: Storage downstairs containing toxic products was unlocked and accessible to children. Operator must ensure that the storage is locked and inaccessible to children at all times.			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (a) labelled with the name of the child.	40(1)(a)	Jan 31, 2024	
Comments: The children water bottles were not labelled with the name. Operator must ensure personal belongings are identified.			
44 An operator of a licensed facility shall have a first aid kit that is equipped with the contents prescribed by New Brunswick Regulation 2004-130 under the Occupational Health and Safety Act as a first aid kit that is not a personal, Type P first aid kit, and a telephone in working order (c) on each outing.	44(c)	Jan 31, 2024

Comments: First aid kit is accessible on each outing. However, the up-to-date emergency record for the children's attendance is not. Operator must ensure all contact is up to date.			
48(2) An operator of a licensed facility may supply food to a child receiving services at the licensed facility that a parent or guardian of the child brings from the child's home if the food is labelled with the child's name and refrigerated, as required.	48(2)	Jan 31, 2024	
Comments: Food brought from home is to be labelled. Lunchbox, containers, sandwiches, were refrigerated but not labelled.			

<p>General Comments</p> <p>During the renewal inspection, the inspector observed the children playing freely indoors, snack, meal and nap time. Positive interaction between operator and children are observed.</p> <p>Ratio is respected during the renewal inspection.</p> <p>Discussion with the operator took place regarding bringing the children outdoors weather permitting each day during morning and afternoon.</p>
