A discussion is held with the operator to clarify that eligible educators must complete the required 10 hours of professional development before the permit expiration date of December 31, 2025.

The inspector had a discussion with the operator regarding the cleaning products. The operator indicated that these products are kept in the kitchen, locked and inaccessible to children.
