Comments: Deficiency is now compliant Observed two packages of Clorox wipes in the 3's classroom that were out of the children's reach, but not locked. Director locked them at time of visit. Observed a bottle of Fabreez that was in the 4's classroom. Bottle was up high out of the children's reach, but not locked. Director locked up the bottle at time of visit.

General Comments
<p>All preschool classrooms were preparing to go play outside when I arrived for today's monitoring inspection. Infant educators informed me that they were outside earlier this morning as there is being work done in their outside play space, resulting in them having to create a schedule to use the preschool space to ensure they are not out at the same time as per regulation.</p> <p>While outside, educators were observed constantly moving around the playground to ensure they could properly supervise the children while they played.</p> <p>Observed positive child guidance practices such as offering choices and assisting children in decision-making and using gentle reminders when needed.</p> <p>The facility's indoor environment offers a very bright and caring atmosphere for children to grow, learn and thrive in. The preschool and infant classrooms have an abundance of learning materials that meet the interests of the children. The indoor environment is also set up in a way that promotes independence by having all play material on low shelves so that the children can pick and choose what they wish to play with.</p> <p>Facility's hallways and classroom walls are lined with children's artwork and learning stories.</p> <p>There is a shelf in the two-year old's "lunchroom" that appears to be starting to droop/angle downwards, educators appear to have put rubber matting on the shelf so that whatever they put on it doesn't slip off. Please ensure to have it fixed/reinforced/levelled as soon as possible to avoid items falling off the shelf and possibly injuring a child or staff. Until shelf is fixed, it is recommended that nothing be kept on it for safety reasons.</p> <p>A reminder to inform your Quality Assurance Monitor prior to the start of any renovations, inside or outside as many renovations require additional documents to be filled out and inspections when work is completed by licensing parties (EECD Inspector, Public Health, or Office of the Fire Marshal). Infant outside play space has been made larger and new fencing is being installed, this will require a "Change in Service" form and an onsite inspection/remeasure with your EECD Inspector when work is complete. Quality Assurance Monitor will provide a copy of the form via email.</p> <p>A reminder that only diluted spray bottles (diluted quat, diluted bleach) used for cleaning tabletops, change tables and toys are not required to be locked, but must be always inaccessible to children. These spray bottles must also be labelled with contents.</p> <p>Observed the four-year-old children going upstairs as a group to wash their hands before lunch at time of inspection. A reminder that Wise Owl Early Learning Center is licensed on the main floor and not upstairs,</p>

meaning they cannot use the upstairs licence's space. Educators can use this transition time to sing songs, play small games, etc, with the children while waiting in the classrooms for the washrooms to become available to them to wash their hands.
