| <p><b>General Comments</b></p> <p>Upon arrival of licensing staff, the children were finishing up snack. The children's water bottles were out and available to them. After snack, hands were washed and they went to the playroom. The children showed licensing staff a "love bug" activity they had done earlier in the week where the children matched coloured stickers with the coloured bugs on the papers. In the playroom, the children were seen playing, climbing, and jumping on the soft blocks. The operator was heard cheering on the children as they climbed and helped when needed. The children played on the balance beams, and one played with the kitchen and food. The children were seen playing with a "fire" and roasting toy marshmallows on the fire. The operator changed diapers and some used the washroom.</p> <p>The operator took out a coloured board, and the children were poking coloured popsicle sticks on the matching colour. Some children were seen playing with a heart tic tac toe that the operator had made. The children and operator were heard singing songs together. One child took out "story stones". Various images were painted on stones, and the operator and child were creating a story with the different images.</p> <p>The children and operator then returned upstairs for lunch. They washed hands and sat at the table. The operator helped the children with their lunches and sat with them as they ate. After lunch, they washed hands. The operator changed diapers and got the younger children settled for nap time and was going to have quiet time with the older children.</p> <p>The operator is attentive to the children, plays with them, and speaks kindly to them. Child files were checked and found to be complete. Only positive child guidance was observed.</p> |
