| <p>General Comments</p> <p>Upon arrival of licensing staff, the children had not returned from school yet. The educator met the children, and they walked down to the classroom together. The children put their jackets and bookbags away and the educator took attendance. The children engaged in free play. Some played with Legos, some did art, and others played tic-tac-toe. A group of children were creating walls and structures for their cars and trucks. The educator was engaging in conversation with the children and preparing the activity. The educator and the children cleaned up for snack. The educator cleaned the table, the children washed their hands and got settled at the table. The children are familiar with the routine.</p> <p>After snack, the children engaged in free play while the others finished eating. The children put their lunch boxes away and the educator cleaned the table. The children wanted to listen to music and were observed singing to the songs. The educator set up the activity at the table. The children were going to be decorating wreaths that will be donated to the community wreath fundraiser. The educator set out wreaths and various ornaments and materials to decorate. Some sat at the table for the activity and some children chose to continue their play. Some children played with balls, trucks, and some engaged in imaginary play. The educator was helping the children and engaging with them. The educator updated the attendance as the children left.</p> <p>The indoor environment was clean. Resources are accessible to the children on low shelves. Various materials are available such as, blocks, costumes, a kitchen, cars, art supplies, board games, and card games. The walls are decorated with pictures of the children and their artwork.
