| <p>Upon arrival, the children were playing outside. The outdoor play area is fenced in with trees, plants and grass throughout it. There were three children present and they were engaged in water play and climbing in and out of a wagon. The children eventually transitioned into the house where they were changed and washed up for lunch. Children bring their own lunches and snacks to the facility.</p> <p>The Operator was observed helping one of the infants eat, and engaging the children in conversation as she encouraged the other children to eat. The children were often offered choices out of their lunch.</p> <p>The environment is set up with materials that the children are currently interested in. Currently the interests include baby dolls and how to care for them. An area specifically with high chairs, cribs and strollers were set up for the children to explore with. The Operator also stated that the children love building with magna tiles, the play couch or with marble runs. It was stated that often, the children will make ramps. The children also have access to other dramatic play materials such as costumes, puzzles, art materials and a sensory table. Since last visit, a quiet area in a Wardolph play house has been added with books, an electric photo frame and other cozy materials.</p> <p>Documentation was observed throughout the play area. Photos of the children, the children's artwork and learning stories were evident.</p> <p>The Operator is now resting some of the children in the main part of the house. The infants are napping in cribs in two rooms while another child is sleeping in the nap room off of the play area. The Operator has a monitor and is doing 15 minute physical checks on the children.</p> <p>All documentation was verified for licensing purposes and is kept in an organized fashion.</p> <p>Also, as discussed, if you wish to add transportation to your license, please forward a change in service application and copy of insurance stating that you are covered to transport children for daycare purposes to your Quality Assurance Monitor.</p> |
