Children's learning is documented and displayed in the learning environments. Recommending that the dates be added to the documentation.

There is a wide variety of age-appropriate materials for the children to interact and engage with in both schoolage rooms.

Educators were observed speaking kindly and appropriately to the children during the inspection.
