General Comments

The children were engaged in free play this morning in the sunroom playing with blocks and books. The operator mentioned gym time and the children moved to the living room space for dancing with a video. The children were familiar with the video imitating the actions and movements. Children then got ready to go to the nearby park, two children went in the stroller while three walked with the operator and her daughter. At the park, the children played hide n' seek, running races, and went on the swing and slide with support. When it was noticed some children were getting tired, they walked back to the home to wash up and begin eating lunch. After lunch, the children have some more free play while everyone finishes and then a story before naps. The operator and her daughter were observed being patient with the children and supporting their independence.

There is a large play structure in the back yard that the children were on before heading to the park. There is no protective surfacing under the structure, but the operator said she will no longer allow them to use it as it is not really in their outdoor play space, she has it for home use with her own children.

A review of child files, daily information sheets and attendance records were conducted, and some items noted Page 1 of 2

in child files. Attendance records and daily information sheets were kept up to date.

The operator is documenting children's play with photos on the wall, and I encouraged her to extend this with connections to the curriculum. We discussed how she is planning for children's play, and I suggested a journal to document children's interests, strengths, and weaknesses so she can plan on what invitations and resources to provide.
