<p><b>General Comments</b></p> <p>Children were engaged in free play while everyone arrives and then went outside for an hour this morning. The outside space includes a sand box where children enjoyed playing with sand toys. Several ride on cars allowed children to drive around and be pushed throughout the outdoor space. Two slides, a house and two kitchens are present with materials located throughout the area. Standing water was in the tires present so some holes need to be placed in the tires to avoid any standing water. There were some broken toys in the outdoor area and no resources included with the kitchens so the suggestion was made for a cleanup. The operator noted she will be purchasing new toys in the near future especially with winter coming. Children's files were reviewed as they are organized within a binder. Some items need to be updated in children's files. A parent board is located within the front entryway and needs to be updated with the current Quality Assurance Monitor and Inspector and be sure to post the most recent renewal inspection and monitoring inspections. Documentation is posted on the wall with photos and learning stories with links to developmental skills</p>
