General Comments

A Monitoring Inspection occurred on April.11/2025. Inspector arrived at the facility around 11:15am and group was not at facility. Inspector returned before school dismissal. Children were on an outing at the Grand Manan nursing home in the morning. During the afternoon monitoring inspection, children were observed engaging in indoor free play. Children created paper mâché on balloons and continued to work on each of their displayed artwork. Positive child guidance techniques were consistently observed, including educator interacting at the children's level, providing appropriate supervision, using positive language, offering choices, and supporting

decision-making. Outdoor play occurs for at least one hour in every four-hour block. The daily routine and weekly menu, including substitutions, are posted in each room, and evacuation procedures are displayed prominently. Life-threatening allergies are clearly posted, and allergy information is accessible in the food preparation area. Books reflecting children's interests were accessible and various forms of props and materials were observed and accessible. Well-defined learning and play areas were observed, with children's artwork displayed throughout. Traffic areas and outdoor walkways were clean and clutter-free, and toxic products were securely stored out of children's reach. Drinking water was available throughout the afternoon, as well as snacks.
