Children were observed during outdoor play and snack time. Proper handwashing was observed before snack. Steps or platforms are provided to allow children to reach regular-sized toilets or sinks.

Educators stated that the children are currently interested in numeracy, literacy, loose parts, outdoor nature walks, studying animals in their environment, a pizza-making centre, homemade binoculars, play scarves, wooden blocks, and a mark-making sensory tray. Educators have included themselves and their interests in the documentation. Photos of the children were observed throughout the centre in various ways, including on materials, schedules, and handmade family blocks created by educators.

Outdoors, educators were actively engaged and playing a meaningful role in the children's activities. Several forms of documentation were observed throughout the facility. Educators provide opportunities for the curriculum to be extended outdoors, and efforts are made to bring the natural world into the classroom. Webs have been completed with the children and have been expanded upon by educators.

The daily incident log is maintained. A clearly visible and prominent location is available to post the license, current inspection and monitoring reports, and any orders for compliance. The daily routine is posted as visual schedules. Evacuation procedures are posted in a prominent location. Life-threatening allergies are posted. A notice informing parents of the existence of a communicable disease is posted and clearly visible.

The rooms are thoughtfully arranged and inviting, with materials that encourage children to play. Books have been selected based on the children's interests. Children's artwork has been displayed at eye level, with their names and dates included. Well-defined learning and play areas were observed, and several pieces of children's artwork were displayed throughout the facility.
