General Comments

Name of operator

A renewal inspection occurred today.

Inspector observed the children from all four learning environments actively engaged in activities outside in the outdoor classrooms, indoor classroom, snack, lunch and nap/quiet time.

During the inspection the children spent most of the day in the outdoor classrooms as well as the trails and surrounding wooded areas at The Park. Inspector observed the children climbing rocks, creating art, morning meeting, building with sticks and branches, playing a made-up game of "Polar Bear", and collecting leaves. Discussions were observed between the educators and the children about what they were seeing and hearing. Educators were also observed comforting children when they fell or tripped and tending to their needs. Inspector went for a walk with one of the groups through the "Vanished Kingdom" to "Rocky Point". There the children were observed building with branches, a wooden bridge was observed that the children had constructed. The overhead canopy of branches and leaves provide an abundance of natural shade. While walking through the wooded area it was observed, by the Inspector, other groups of children from the park campus with their educators exploring the trails and outdoor classrooms. One group of children was observed in their outdoor classroom having their lunch on a tarp that was placed on the ground.

In each of the indoor learning environments natural materials were observed available for the children to interact and engage with. During a washroom break, back inside, it was observed the children engaged in the different interest centres while they waited for their peers to finish before proceeding back outside.

General Comments

Educators indicated that the children spend most of the day outside, except for washroom breaks, and nap/quiet times for children who sleep.

All staff files were reviewed and verified complete except for one missing a job description and signed statement.

Educators in the groups were observed speaking kindly and appropriate to the children using positive child guidance techniques.
