General Comments
<p>A monitoring inspection occurred on December 19, 2025.</p> <p>Children were observed in Room 5 only as children from Room 4 and 5 were combined at the time of the inspection. The environments in both rooms were observed and inspected. Inspector observed the children during transition times from inside to outside play and outside play to preparing for lunch.</p> <p>In Room 4, children's learning is documented in a binder. Educators indicated that parents/guardians are shared what the children are learning and engaged in on Bright Wheel. Copies of the learning was available for to licensing to review in the binder. Evidence of the children engaged in nature walks, mark making activities, tuff tray exploration was observed documented.</p> <p>In Room 5, documentation of the children engaged in play and learning was observed by the Inspector in the documentation binder. Pictures of the children exploring the outdoor classroom/wooded area, tuff tray exploration, mark making activities, and parachute games were observed. Children's learning in this room is shared with parent/guardians via Bright Wheel.</p> <p>Two new staff files were reviewed and verified completed by the Inspector.</p> <p>Incident logs and attendance records were reviewed and verified completed. Discussions with Educators regarding Incident Reports occurred with all educators to review when these must be sent to Quality Assurance Monitor. Educators indicated they were aware that if a child is hurt and parents/guardians take the child to the hospital or clinic for further observation that the incident report must be filled out and submitted to licensing.</p> <p>Educators were observed, by the Inspector, engaged with the children in their learning and play, tending to their needs appropriately and using positive child guidance techniques.</p>
