Comments: Adequate lighting must be provided for children eating lunch and for children awake during other room's naptimes. Small lamps or strip lighting could be added to provide some soft illumination.							
General Comments							
There was some confusion in regard to the attendance records when licensing staff arrived as educators have been keeping attendance on an app and not always completing the attendance records. Attendance records should be kept up to date at all times in case of emergencies and in the case of an outbreak. Some educators sign in on the children's attendance records which is recommended to ensure ratios are met. Ensure all children, including the operator's children are included on attendance record if they are part of a room. Children in the school age room were engaged in free play throughout their space, some playing basketball and running around in the gross motor area while others were painting and hanging out together beside the couch. The children had a vote on a choice of movie that they were going to watch after lunch which used to only occur on Friday afternoons. Remember television viewing is not to occur daily. The preschool children cleaned up after play and lunch time was offered a bit earlier to meet the needs of the children saying they were hungry. Each of the children have a cot for quiet time and are allowed to choose a container of resources for play. The children partnered with some friends in play from their mats. As many of the children in this group will be attending kindergarten in the fall and may be beyond naps, they could be offered time outside or quiet activities within the classroom instead of designated time on a cot. Cots could be available for any child that wants to rest, if needed.
