General Comments

Children had finished snack this morning and were waiting in the reading corner for clean-up and invitations to be set up. Educators set out three invitations related to the morning story of The Gruffalo, one included glue, paper, scissors, and Gruffalo pieces, the second was loose parts and wood for building a mouse house and a rice bucket was provided as Gruffalo crumble. A timer was used for children to rotate through each of the activities. The educators sat at each of the tables with children and took photos on the Ipad. The educators continued interest in the book with an outside game of What time is it, Mr. Gruffalo? Pylons were set up in the field to allow children to play the game and run around while being aware of the boundaries.

The preschool room appears cluttered today with a lot of furniture. The small room is blocked off and filled with storage and there were bookbags on the floor instead of on the pegs. Please ensure rooms provide enough

space for children to move around freely and items to be picked up to avoid tripping hazards. The small room is to be cleaned out to provide additional play space to children.

Due to requested changes in space, there have been several changes in children and staff. Please ensure all administrators and staff are current for specific licenses. Relocations in space cannot occur until all applications have been submitted and approvals received from Fire, Health, and EECD.
