<p>There was a conversation with an educator and administrators regarding behavior concerns with children. Inclusion support team has been involved and supporting the centre.</p> <p>Some work was being conducted in the small room in the preschool space. A bookcase was placed across the door to ensure children could not enter but a reminder was given to conduct any work to the building after hours when children are not present.</p> <p>There was a conversation about the renovations occurring next door and a reminder that no changes can be made to the initial plans sent to fire and health for approval.</p> <p>The child files and staff files have been updated, and the fire extinguishers were being replaced while licensing staff was on site. The outdoor checklist has been created and placed on the door to outside to ensure it is completed regularly. Fire drills have been completed.</p>
