General Comments

Upon arrival licensing staff noticed that the operator had replaced the steps going into the main door. There is no longer a high step to get into the home which has made accessibility easier for the children.

The operator has opened up their living room space as they found that the children needed more room for their play. There are a variety of materials available to the children and it includes a kitchen, dress-up clothes, child size materials for cleaning, blocks, dolls, trucks, wooden blocks, mega blocks, dinosaurs and figurines, board games, magnetic tiles and blocks and many art materials and a cozy corner with accessible books for the children. The Operator adds more materials as needed.

The children bring their own snacks and lunches to the home. The operator is attentive to the children's needs and was observed as kind and patient. They were seen giving gentle reminders such as "please use gentle hands" and would give praises to the children many times throughout the day. The operator is very respectful towards the children; they would ask them if they were ready to begin a task or to go outside. As one of the children became very upset at the time of visit, the operator responded in a calm and gentle manner while validating the child's feelings.

The first aid kit left the home with the Operator as they were going outside. The first kit now matches the expectations of the Worksafe NB regulations. The operator's first aid certification is still valid but has enrolled for a course as it expires in July.

Children under 15 months sleep in play pens and children older than 15 months sleep on cots. Licensing staff discussed the use of the family beds with the Operator and they were advised that they can use them providing children have their own bedding, there is a safety rail so that the children do not fall off and the upper use of bunk beds are not used.

The operator is using lesson plans and a newsletter to document a pre-planned program. They also post pictures of the children's learning on the wall for the month and keep it on file.

The Operator's Filing system is organized and complete. Attendance records, infant/toddler sheets,

medications records, potential illness, exclusion forms, and fire drill records are being kept on file and used as necessary. Also visible were nap checks, cleaning records, and "owie" reports. There have not been any reportable incidents this year.

Licensing staff can now recommend facility for licensing.
