General Comments
<p>-Morning visit to the center for an unannounced monitoring inspection</p> <p>-Ratio was respected during the visit</p> <p>-Outdoor space provides a safe environment for children from all ages (infants, preschoolers, and school age kids) to play and explore. Material proposed is sufficient in variety and quantity for the number of children attending the center. Shaded area is provided in both play area.</p> <p>-Children's guidance is done in a respectful and positive way</p> <p>-The diaper changing station provides individual space for diapers and changing necessities. The changing table is equipped with a safety strap and covered with a non-absorbent layer, it is separated from the food preparation and is located one meter or less from a sink and children are always supervised during diaper changing.</p> <p>-Centre has the proper number of functioning and available toilets and sinks, a training seat is provided, and a step or platforms are provided to allow children to reach regular sized toilets or sinks.</p> <p>-Napping equipment is washable and non-absorbent and the required spacing between the beds is respected.</p> <p>-Each cot is stored in a way that there is no contact with another napping equipment and-or are disinfected on both sides after each use</p> <p>-Each child under 15 months has a designated crib that meets the Cribs, Cradles and Bassinets Regulations and the Playpen's Regulations under the Canada Consumer Product Safety Act</p> <p>-Medicine must be kept under key, eye drops were on a shelf out of reach of the children but not kept under key, it was suggested to add a small box on which a pad key can be added in each room. No medicine must be left in the children's bags or lunch box. Eye drops were stored in the lock closet before leaving.</p> <p>-When a child who becomes ill, he/she is supervised and separated from the other children. That child is to be</p>

picked up within one hour of notification to parents.

-Medicines are labeled with the child's name and in the original container, otherwise staff cannot administer the medication.

-One staff had to go home because her criminal-vulnerable sector check wasn't valid. She will be able to come back to work once her documents are in order.

Observations: When arriving at the center children were going outside, when coming in they all got into free play, transitioned into lunch, and then nap time for the infants and the youngest preschoolers.
