General Comments

- -Early-morning visit to the establishment for an unexpected monitoring inspection
- -Ratio was respected in all groups during the visit
- -The daily information sheet for infants (0-24 months information about the child's mood, eating schedule, rest time, diaper changing) is completed every day and stored at the end of the week in a file in the office
- -All children's have the required document, also consent forms are signed and dated by a parent/guardian
- -New staff records contain required checks and documentation
- -The administrator as well as educators have a valid first aid certificate, one new staff will be getting her first aid certificate next weekend.
- -One new employee is registered to her 90h-Introduction to early childhood course, her training starts in August 2026
- -Review and discussion about the major incident report form. It was discussed with the director what incident is considered reportable
- -Minor incident reports are maintained in the child's file
- -Daily routine into the center includes; Outdoor play time at least once every 4 hour blocks time when the weather is permitting. Meal and snacks are served at the recognized hours and a daily rest period that meets the children's needs.
- -It was observed during the visit that when in a situation of misunderstanding, children's guidance is done by asking open end questions and staff provided support towards problem solving to allow children to find a solution together.
- -Administrator confirms that the sheets that are used for the cribs are washed by the staff since they belong to the establishment, but other sheets and all the blankets are sent home at the end of the week to be washed by the parents
- -The designated napping spaces within the center are the classrooms for children between 15months to 4 years-old and a separate room for infants 0-15 months.
- -Each cot and is stored so there is no contact with another napping equipment, each child has it's own cot which is labeled with his-her name and at the end of the week each cot is washed
- -Diaper changing station are found in the washroom on the main floor and the washroom in the three-year-old room upstairs, individual space is provided for diapers and changing necessities. The changing table is equipped with a safety strap and covered with a non-absorbent layer, it is separated from the food preparation

and is located one meter or less from a sink and children are always supervised during diaper changing.

-In each room documentation on an outdoor challenge was obvious, I could see a lot of outdoor material into the rooms that was made available to the kids.

-Specific information about each child is posted into the infant's room, so any relief staff will know which song, food or toy is their favorite or who needs a soother or a favorite blanket

Observations: When arriving at the center all children were getting ready to go outside to play, the infants were all up and ready in their strollers for a walk. When coming in from their outdoor time everybody washed their hands, diapers were changed, and lunch was served. All infants and younger preschooler were put down for their nap and staff go busy with their cleaning.
