<p>Comments: During the inspection, the inspector observed that only the administrator and 4 educators out of 10 hold a one-year certificate in Early Childhood Education. Regulations require that 50% of educators possess this certificate or an equivalency recognized by the Minister. For this facility, 5 of the 10 educators must hold a one-year Early Childhood Education certificate. A plan must be submitted to the Quality Insurance Monitor stating how the 50% regulation will be met.</p>
