General Comments
<p>A Monitoring Inspection occurred on March 11, 2025.</p> <p>Children were observed during indoor free play and transitioning to outdoor activities. Proper handwashing was noted during mealtime and when coming inside. Steps or platforms were available to help children reach regular-sized toilets and sinks.</p> <p>Educators shared that the children are currently interested in active outdoor play, painting a cardboard box school bus, exploring sensory trays with natural items and letters, learning sign language, and creating blocks with family pictures. Educators were observed using positive language and providing gentle reminders.</p> <p>The facility maintains a daily incident log, and parents of enrolled children can enter the center at any time. Outdoor play occurs for at least one hour in every four-hour block when most children are present, weather permitting. The daily routine is posted in each room, and evacuation procedures are clearly displayed in a prominent location. Life-threatening allergies are also posted.</p> <p>Books reflecting the children's interests have been selected. Well-defined learning and play areas were observed, and children's artwork was displayed throughout the facility. Traffic areas, including outdoor walkways, were clean and free of clutter. The changing area is located within one meter of a sink. Infant bottles are labeled and used only for the intended child. Allergy information is posted, and the infant outdoor play area is either separate or used at different times than other age groups. Outdoor equipment is surrounded by protective surfacing of appropriate depth.</p> <p>Several forms of documentation were observed throughout the facility. Educators provide opportunities to extend curriculum outdoors and incorporate elements of the natural world into the classroom. Webs have been completed with children and expanded upon by educators.</p>

General Comments

A discussion took place with the Administrator regarding the facility's strengths and areas for improvement. Strengths included the presence of various forms of literacy in the indoor environment, welcoming educators, and well-maintained spaces. Areas for improvement included ensuring children bring water bottles outdoors, documenting fire drills separately for each licensed facility on-site while completing them simultaneously, and storing personal blankets separately.
