## Comments:

Inspector observed mandatory attendance records in Room 4 for December 1, 2025, that the children were not signed out upon departure at the end of the day. Discussed with Administrator on site, who showed Inspector that on Bright Wheel the children had been signed out. Discussed with Administrator that the attendance records must be filled out daily and accurately reflect the number of children in care at any given time. Administrator transferred the information from Bright Wheel to the attendance records while Inspector was present.

Deficiency is now compliant.

## **General Comments**

A renewal inspection occurred today.

Upon arrival at the child care facility, Inspector observed that the children were transitioning to outside play as some were finishing their morning snack.

In the two infant rooms, Inspector observed displayed on the walls and in a binder, evidence of a mark making web, pictures of the children engaged in mark making, exploring with paint, and going on nature walks. Pictures of the children scooping, pouring, and filling in the tuff tray was displayed in the rooms. Inspector observed a tuff tray set up with a "wash the toys" station for when the children returned from outside play. The children were observed going for a walk through the trails with their educators.

In Room 2, a two-year-old room, evidence of the children's learning is displayed both on the walls and in a binder. The children have been exploring and creating with playdough, painting rocks, nature walks, rock hunt, climbing in the outdoor classroom and exploring the trails. Pictures of the children developing their fine motor skills by using scissors and paper was observed by the Inspector. Children have also been exploring heavy play by using gross motor skills and large muscles by pulling and pushing the wagons with leaves to explore that they had collected. The children were observed playing outside with leaves and trucks in the outdoor trails/classroom.

General Comments					
In Room 3, a two-year-old room, the children are beginning a project on community helpers. Inspector observed pictures of the exploring leaves outside, creating with paint, playing in the snow, practicing fine motor skills by using scissors to cut paper was displayed walls as well as in a binder within the learning environment.					
Upon arrival to room 4, mixed preschool age group, inspector observed the children transitioning too outside. The children have been exploring measurement. Inspector observed documentation of the children measuring how far they can jump off when standing on a tree stump and the educators creating a mark where they landed by making a line on the ground. Documentation of the children using different lengths of ribbon to determine how big a pumpkin is displayed on the walls on the learning environment.					
When outside all groups were observed exploring the Vanished Kingdom trails with their educators, playing in the leaves, climbing rocks and stumps, exploring the trails.					
Transitions from outside to inside for lunch and nap time was observed occurring naturally within the learning environments. Inspector observed diaper changing and handwashing occurring numerous times during the inspection.					
Inspector observed the educators in the rooms speaking kindly and appropriately to the children, tending to their needs, and using positive child guidance techniques.					
Facility is recommended for license renewal.
