<p>Monitoring Inspection:</p> <p>Children and educators observed during arrival, transition to outdoor play, snack time and outdoor play.</p> <p>Educator was observed conducting a headcount and completing the daily attendance form when the children arrived at the bus stop.</p> <p>The indoor play area is set-up with a variety of materials and invitations for the children to explore freely. The indoor play area is organized and appears to be well-maintained.</p> <p>The educators use a wagon to hold outdoor play and art materials for children to use on their outings to the field and picnic shelter. Children were observed choosing board games to bring with them to play at the picnic shelter. Children were observed enjoying their afternoon snack (cucumbers, carrots, fajita wraps and tzatziki) on the deck by the lake.</p> <p>Handwashing routines were observed at arrival and before snack time.  Children were observed applying sunscreen before outdoor play.  Random review of staff files (2) was completed, all required documents are in place.</p>
