Children were engaged in play when licensing staff arrived. One of the educators was setting up a small table with shaving cream for the children to explore, putting animals in and covering them with cream. The second educator was sitting with children as they drew and colored. Children were dancing and moving while watching a video. Magnetic blocks, cubes, beading, table tennis, and bey blades were set out as invitations for play. One child was curled up on the bean bags reading a chapter book fully embracing the comfort of this space. The environment supports children's multimodal literacies through videos, books, dancing, creating, drawing, writing, games, and music.

The educators reminded children of the rules and tried to help children problem solve disagreements. One educator turned questions back to children encouraging their critical thinking skills. Children frequently washed their hands and lined up to wash after clean-up and before snack. The educators were observed cleaning tables after play, before and after snack.

Children began a limbo game, and most children joined in. The educators supported their game by holding the rope and placing tape on the floor for two lines of participants. The reading corner was later used as a space for several children to lay on the bean bags and have a discussion although this evolved into stacking the bean bags on one child which one educator interrupted by reminding children of the rules about the bean bags.

Children were provided a snack of banana break, fruit, and milk as posted on the menu. Rice Krispie squares were also available. Children sat at the tables eating with their friends.

Child files were reviewed, and it was noted several files were missing a doctor's name and contact information. Due to the number of families without a family doctor in New Brunswick, the recommendation is for parents to list their local clinic in the place of a doctor's name.

Children moved around the room and chose resources with confidence showing they are comfortable in the environment. Educators gave familiar expressions, "eyes and ears on me" to remind children of upcoming transitions. A final cleanup occurred when the majority of children were finished snack allowing any children still eating time to finish. The children and educators then went outside to the playground.
