### **Interim Professional Learning Guidelines - Anglophone**

This document clarifies the current professional learning activities recognized under designation for the anglophone sector effective July 24, 2023. Revisions to the previous professional learning guidelines have been made in response to the challenges expressed by the sector regarding the need for increased access to more professional learning to meet designation requirements.

## Please Note: It is the responsibility of the operator to ensure the educators working in their facility complete all Professional Learning requirements.

Early Learning and Childcare Licensing staff will not typically require a review of learner reflections. However, if training clarification is required for designation purposes (either the number of hours, or the type of training, etc.), they may need to review the learner reflection form.

All other sharing permissions will be at the discretion of the learner.

<sup>&</sup>lt;sup>1</sup> If no certificate is issued, educator may record the following information on a separate document for validation: their name, date, name of event, number of PL hours and the presenter/organizer name, and operator signature. If provided, an agenda or description of the event could also be included.

<sup>&</sup>lt;sup>2</sup> A reflection form is provided in Appendix B for learners to deepen their thinking on a professional learning experience. Operator may require that the learner share the reflection for the purposes of supporting professional growth, to support annual reviews, or QIPs.
