Comments: One child can open the gate and allow access to the hallway so ensure all doors are locked. Ensure the closets and cupboards do not store anything unsafe.			
36(3) The rest area of a full-time early learning and childcare centre and an early learning and childcare home shall be equipped with the following: (a) a crib or portable playpen for each child under 15 months of age in accordance with the Cribs, Cradles and Bassinets Regulations and the Playpens Regulations under the Canada Consumer Product Safety Act (Canada).	36(3)(a)	Feb 13, 2025	
Comments: The playpen has a plastic cover that must be covered with a sheet so the child is not sleeping on plastic.			
36(4) The rest area of a full-time early learning and childcare centre and an early learning and childcare home shall allow for a space of at least 46 cm between each crib, portable playpen, cot or nap mat.	36(4)	Feb 13, 2025	
Comments: Ensure cots are placed the appropriate distance apart.			
41(1) A licensed facility at which services are provided to children who wear diapers shall have a sturdy surface that is (b) covered with a non-absorbent layer.	41(1)(b)	Feb 21, 2025	
Comments: There is a rip in the changing pad so this needs to be covered or replaced.			

General Comments
Children were just waking up when the Quality Assurance Monitor arrived. Child files were reviewed and some suggestions made to ensure required information is included in each file. If a family does not have a family doctor, they can note the local health clinic they visit.
Documentation is posted on the wall of children's photos with a description of their play, who is involved, and quotes from the children. The next step will be making connections to the curriculum to highlight the learning children are engaged in. All the photos and children's artifacts are posted down at their level in page protectors so they can revisit their learning.
Children went to the washroom when waking up from naps. After some time playing, they got ready for snack by

washing their hands and going to the table. The children played with puzzles at the table before snack and everyone got involved at the table or in a highchair.

Ensure younger children are observed at all times when doing bum changes or eating. A solution can be to take younger children in the hallway outside the washroom to view and wait for bum changes and hand washing until all children have finished eating.

Cleaning was observed before and after snack as well as vacuuming and clean up while children are napping.
