<p>General Comments</p> <p>Upon arrival of licensing staff, the children were getting settled for snack. Music was playing in the background, and the operator was heard singing to the children. As the children finished eating, they washed their hands and played until the others finished. The operator cleaned up the table and then played with the children. They played with blocks and played in the play kitchen. The children were making food, and the operator was engaging in their imaginary play and "eating" their food. The children and operator danced and sang to various songs together.</p> <p>The operator then set up a mat and a sensory bin with dry noodles, pots, bowls, and utensils. The children and operator played together and made food. The operator brought plastic bottles out and the children and operator added noodles to the bottles and were seen shaking them to make music. The children and operator cleaned up the bottles and noodles and got settled at the table to do board-puzzles. After playing with the puzzles, the children gathered on the cushions for story time. The operator was showing the children the book and letting them touch the textures on the animals from the story. The operator then took out cards with animals on them. The operator would show a card, say the animal, and the children would repeat.</p> <p>The children then washed their hands and sat at the table for lunch. The operator helped them get settled and sat with them as they ate. The operator greeted the parent and child that arrived at lunch time and helped the child get settled for lunch. The operator is attentive and talks kindly to the children. Learning stories are posted at the children's eye level for them to reexplore. Only positive child guidance was observed.</p>
