General Comments

Licensing staff arrived to conduct the renewal inspection. Upon arrival, the children and Operator were preparing to go outdoors to play. The Operator assisted the children with getting their outdoor wear on, the first aid backpack was picked up and a headcount was observed before leaving the doorway.

Once outdoors, the children were observed playing with trucks, on the swing set, gathering fallen apples, baking pretend cupcakes at the wooden mud kitchen and using the wooden ball ramp. The Operator was actively engaged with the children in play and was heard reflecting with the children on past outdoor play activities. Before coming indoors for lunch, a one minute "let's get ready to go indoors" announcement was heard and the children gathered and walked to the door.

The indoor space was neat and play material such as wooden blocks, dinosaurs, books and a wooden play kitchen with accessories was organized, in good condition, and easily accessible. Current learning stories with photos of the children were posted throughout the space and a pumpkin patch wall hanging with felt cut outs was set up in the circle time space. A sensory bin with corn flakes and Halloween loose play pieces was set up in the corner. While sensory play provides a thorough sensory experience like crunch, smell, texture, visual, and at times taste, modelling exploration and sitting with the children is recommended.

Before lunch, a cleanup song was heard as the Operator encouraged the children to tidy up the play material. Diapers were changed, and proper handwashing was observed. During lunch time, four of the children sat together at a low table while one of the infants sat in a highchair. As the children finished eating, the curtains in the main space were drawn and nap cots were prepared. During nap time, a soft night light was turned on and the Operator was observed tucking the children in with their blankets.

During the inspection, files were verified and required licensing documentation was present. Monthly fire drills are being conducted, a cleaning schedule was noted, and daily information/attendance forms are being completed. Only positive child guidance was observed during disagreements between friends. Gentle redirection and reminders were heard as well as demonstrations on gentle hands and respecting personal space.
