Comments: Monthly emergency evacuation and fire drills have not been completed for January 2026. Monthly emergency evacuation and fire drills must be conducted and recorded each month.			

General Comments
<p>A monitoring inspection was conducted on the morning of February 10, 2026.</p> <p>The children were observed in both the indoor and outdoor environments, including during transitions between the two. Additionally, the children were also observed eating snack, with handwashing occurring beforehand.</p> <p>Indoors, the children were observed in building with magnetic tiles and playing with farm animals and Little People figurines. Outdoors, they were observed making snow angels, using the teeter totter, and sitting on the toy bus.</p> <p>Several forms of documentation were visible, including learning stories, photographs, and children's artwork. The room was well organized and inviting, offering a variety of appropriate materials, books, and toys.</p> <p>The operator demonstrated positive interactions with children by using encouraging language and gentle reminders. The operator asked open ended questions, listened actively, and extended children's ideas through conversation.</p> <p>A clearly visible and prominent area was designated for posting the facility license, current monitoring reports, and any orders for compliance. Additional documentation observed included incident logs, daily attendance records, daily information sheets, and monthly emergency evacuation and fire drill records.</p> <p>A discussion took place with the operator on the following:</p> <ul style="list-style-type: none"> Ensuring that children's learning is recent and visible through documentation (e.g., collections and samples of artwork, photographs, and project work).

General Comments

- Ensuring that both the recent monitoring inspection and the renewal inspection are posted and visible.
- Ensuring that personal belongings are labeled with each individual child's name
- Recommending hand washing signs are posted wherever hands are washed.
