## **General Comments**

A renewal inspection occurred today.

Upon arrival for the inspection, Inspector observed the preschool children preparing to go outside and play in the rain. Once outside the children were observed jumping and splashing in the puddles, playing with trucks in the mud and running through the rain and puddles.

The children were also observed during inside play, having lunch, quiet time, afternoon snack and transitioning to outside afternoon play.

In the indoor environment in the preschool, it was observed the children's current interests is Christmas and the children were observed creating and decorating a Christmas tree that was drawn on paper. Educators also indicated that one of the children is interested in toads and they will begin to foster that interest with songs, books, and invitations. Inspector observed the educators and children singing "Five little speckled frogs" during the inspection.

Children in the preschool room were also observed engaged in tuff tray play where animals, and loose parts were placed. The children were also observed building with blocks.

In the school-age room, a cozy corner has been created in one of the lofts and a dramatic play/kitchen created in the other loft. A variety of boards games, Lego, art materials, age-appropriate books were also observed. It was observed during the inspection that one corner of the room had boards and sticks piled on the floor. Administrator indicated that the educators are working on an entrepreneurship with the children, and they will be creating items for Christmas.

All staff files were reviewed and verified complete. A random review of ten children's files occurred and were verified complete.

Upon arrival from school, Inspector observed the children arriving the bus, transitioning to handwashing, and

transitioning to outside play.

During outside play, the Inspector observed the children playing basketball, soccer, swinging on the swings, exploring the wooded area, and outside snack.

Educators were observed speaking kindly and appropriately to the children during the inspection.

Discussed with Administrator, Appendix 15: Incident reports. These must be completed and submitted to the childcare facilities Quality Assurance Monitor if Public Health has declared an outbreak at a childcare facility. Discussed Benefits of Inclusion training for Inclusion Support Workers. This must be completed within three months of a staff member becoming an Inclusion Support Worker and placed in the staff member's file. If the support worker is working with infants or preschool aged children, they must also complete the thirty-hour curriculum training. A copy of the enrollment/completion of this is to be placed in the staff member's file. Facility is recommended for license renewal, pending the recommendation from Fire.
