General Comments
<p>A Monitoring Inspection occurred in the afternoon on December 11, 2025</p> <p>The children were observed in both the indoor and outdoor environments, including transitions between the two.</p> <p>Indoors: The school-age children were engaged in a variety of activities, including building with Lego, playing basketball, and creating open-ended art at the table. Several children were observed eating snack, with handwashing occurring beforehand.</p> <p>Outdoors: The children were observed sliding down the hill on sleds, throwing snowballs, building snowmen, and using shovels to dig in the snow.</p> <p>The educators indicated that the children are currently interested in outdoor activities, specifically sliding, as well as art activities such as painting, and listening to music.</p> <p>Documentation was visible throughout the room, including photographs and individual and collaborative artwork.</p> <p>Educators demonstrated positive interactions by using encouraging language and gentle reminders. They asked open-ended questions, listened attentively, and extended children's ideas through conversation.</p> <p>A clearly visible and prominent area was designated for posting the facility's license, current monitoring reports, and any orders for compliance. Additional documentation observed included incident logs, daily attendance records, four staff files, and records of evacuation and monthly fire drills.</p> <p>A conversation took place with the administrator regarding the following:</p> <p>Recommending that educators include more detailed descriptions in their planning book to reflect the intent and outcomes of activities. Adding photos of the learning experiences will provide visual documentation and support a richer understanding of the children's engagement.</p>
