The children were observed engaged in a variety of indoor activities, including drawing, using chalk, playing basketball, and making loom band bracelets.

A clearly visible and prominent area was designated for posting the facility Licence, current monitoring reports, and any compliance orders. Additional documentation observed in this area included incident logs, daily attendance records, three educator files, and monthly emergency evacuation and fire drill records.
