Comments: The outdoor play space is still not meeting licensing requirements. Please remove the broken picnic table, the swings and dome must have clearance around it so that a child would not potentially fall off into the fence or another piece of equipment; the wood that is used as a division in the infant play space is a tripping hazard; please build up surfacing or remove it as discussed; rain fall has made a trench by the exit creating a tripping hazard and must be filled in.			
33(2) Stationary equipment in the outdoor play area shall be surrounded by a protective surfacing and installed according to the manufacturer's instructions.	33(2)	Jun 05, 2026	
Comments: Stationary equipment still requires the appropriate amount of surfacing around it.
