Comments: The Quality Assurance Monitor noted that the facility did not meet the requirement of at least 50% of educators holding a one-year Early Childhood Education Certificate or equivalent. This was discussed with the administrator, who confirmed that one staff member is currently enrolled and scheduled to begin the program in September 2026.

Comments: Compliance with Regulation 28(1) could not be verified, as no one was present on site.
